Social Work Internship Program

The Federal Defender's Office (FDO) employs social workers in both the Sacramento and Fresno offices to counsel and aid clients through various challenges that exist in conjunction with their criminal case. The FDO's Social Work Program is an important component of a holistic approach to meeting client needs. We believe that by helping clients address their social support needs, we enable the best possible resolution to their criminal case AND reduce recidivism risks.

We cooperate with the Federal Court, the Federal PreTrial Services Office, and the Federal Probation Office to address client needs. FDO social workers assist clients with housing, healthcare, difficult family situations, mental health counseling and treatment, substance use addiction treatment, employment and vocational training, mentoring, immigration concerns, and other barriers that our clients face.
