NOTABLE SUPREME COURT CASES

In Evans v. Michigan, No. 11-1327 (2-20-13), the court decided that a criminal trial judge's erroneous midtrial entry of an acquittal, based on a finding that there was insufficient evidence to prove a matter the judge mistakenly believed to be an offense "element," bars retrial under the Double Jeopardy Clause.

In <u>Henderson v. United States</u>, No. 11-9307 (2-20-13), the Court ruled that a trial error is "plain" for purposes of the federal plain-error rule, Fed. R. Crim. P. 52(b), if it was plain at the time of appellate review, whether or not the legal question was settled at the time of trial.

In <u>Bailey v. United States</u>, No. 11-770 (2-19-13), the Court ruled that the rule in <u>Michigan v. Summers</u> that officers executing a search warrant are permitted "to detain the occupants of the premises while a proper search is conducted," is limited to the immediate vicinity of the premises to be searched. Accordingly, <u>Summers</u> did not permit law enforcement to detain a recent occupant of the premises at a point beyond any reasonable understanding of the immediate vicinity of the premises to be searched.
